Parties & Events - How to Book

- Please telephone the hotel to check availability for your chosen dates & to make a provisional reservation.
- Complete the booking form & return it to the hotel with (a) your deposit of a non-refundable deposit of £5 per person for parties or events. Please make cheques payable to the Comfort Hotel.
- For all parties & events, full payment of the balance is required at least 14 days prior to the event or by 21st November 2008, whichever is the earlier.
- Pre-orders for wines are required at least 14 days prior to the event.

Terms & Conditions of Booking

1. All verbal bookings will be treated as provisional & will be held for no longer than 14 days pending receipt of written confirmation & the appropriate deposit.
2. Parties & Events: Bookings not paid in full by 14 days prior to the event or by 21st November 2008, whichever is the earlier, will be deemed to have been cancelled & any monies paid will be retained by the hotel.
No refunds of monies paid will be made for cancellation or decreases in the numbers of guests attending, unless the hotel is able to resell the space.
Monies paid for non-arrivals are forfeited & cannot be transferred to cover food, drinks, entertainment or overnight accommodation for other members of the party.

All events & timings are subject to approval by the local licensing authorities. All statutory licensing regulations apply.
3. This information is correct at the time of printing. The hotel reserves the right to amend its packages & prices at any time before booking. Bookings are subject to availability & prices quoted at the time of booking.
4. Except in respect of changes to the rate of VAT, prices will not change once booking has been made. The hotel reserves the right to alter or amend the contents of an event or package or to cancel an event or package for any reason, for example if there is a shortfall in the minimum numbers required to operate a programme. In such circumstances, and without affecting your legal rights, you may choose at your sole discretion an alternative date, subject to availability or obtain a full refund from us.
5. All prices for Christmas & New Year Residential Packages are in £'s per person per night based on two people sharing a twin or double bedded room. There are no supplements for single bedded rooms. When no single rooms are available, individual guests can usually book a twin or double-bedded room at a supplementary charge. Prices on application.
6. Residential Stayover Rates are only available when booked for stays as extensions to bookings for Christmas Parties.
7. All additional charged incurred during the event must be settled prior to departure.
8. All Prices are inclusive of VAT at 17.5%. If the general rate of VAT is altered, our prices will be modified accordingly. Gratuities are at the guest's discretion.
9. Other than for death or personal injury caused by our negligence, our liability to you is limited to the price of your booking plus expenses directly & necessarily incurred by you to comply with your booking.
10. The hotel will not be liable to you for failure to perform to the extent that the failure is caused by any factor beyond its reasonable control.
